High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

As we enter the final phases of construction to build the new overbridge and connect the realigned A429 Kenilworth Road, we will need to close the existing A429. We will be finishing embankments, reinstating and resurfacing the footpaths, positioning final utilities and completing highway drainage works.

## When will these works be taking place?

In order to carry out the works in a safe and secure environment, we will need to close the A429 Kenilworth Road from **Monday 2 June 2025 to Saturday 28 June 2025,** and from **Monday 30 June 2025** to **Sunday 20 July 2025.** The closures will be in place 24 hours a day.

A fully signposted diversion will be in place during the closure and access to all properties will be maintained throughout. Kenilworth Road and interconnecting footpaths will remain open to pedestrians and cyclists.
